An ordinance to fulfill the requirements of 2004 PA 286-300 to provide for the term and manner of election of General Law Village officers and trustees.

The village council of the Village of Laurium ordains:

<u>Section 1.</u> Three of the Village Trustees shall be elected at each biennial village election for the term of four years and until their successors are qualified. The president, clerk, and treasurer of the village shall also be elected for terms of four years and until their successors are qualified. Elections of village officers and trustees shall occur in the month of November in even years. The township clerk shall conduct village elections.

<u>Section 2.</u> The next regular election for the Village of Laurium shall occur in November 2006.

<u>Section 3.</u> The terms of the following incumbent trustees and officers shall be extended as follows:

- a. The term of Donald Bausano, village president, is extended from March 2005 to November 2006. Donald Bausano was appointed to fill a vacancy for the position of village president. Consequently, he may hold office only until the next election of village officials. The next three elections for the position of village president shall occur in November 2006, November 2008 and November 2012.
- b. The term of Patricia Golus, village clerk, is extended from March 2006 to November 2008. Elections for village clerk shall occur in November 2008 and November 2012.
- c. The term of Jon Koskiniemi, village treasurer, is extended from March 2006 to November 2008. Elections for village treasurer shall occur in November 2008 and November 2012.
- d. The term of Charles Junot, trustee, is extended from March 2005 to November 2006. Elections for his seat on the village council shall occur in November 2006 and November 2010.

- e. The term of Steven Lanctot, trustee, is extended from March 2005 to November 2006. Elections for his seat on the village council shall occur in November 2006 and November 2010.
- f. The term of Mary Turner, trustee, is extended from March 2005 to November 2006. Elections for her seat on the village council shall occur in November 2006 and November 2010.
- g. The term of Kevin Harju, trustee is extended from March 2005 to November 2006. Kevin Harju was appointed to fill a vacancy on the village council. Consequently, he may hold office only until the next election of village officials. The next three elections for the seat of Kevin Harju on the village council shall occur in November 2006, November 2008 and November 2012.
- h. The term of James Köskiniemi, trustee is extended from March 2006 to November 2008. Elections for his seat on the village council shall occur in November 2008 and November 2012.
- i. The term of Anthony Rastello, trustee is extended from March 2006 to November 2008. Elections for his seat on the village council shall occur in November 2008 and November 2012.
