The meeting was called to order in the village council chambers by President Bausano at 5:30PM.

**New Business**

**PA 495** is for Fire Insurance Withholding. Rural Development settled for the property located at 415 Iroquois St where there had been a fire. The owner did not make a claim therefore the PA 495 funds go into an escrow account for the village. A motion was made by Lanctot and seconded by Junot to extend the PA 495 withholding period until the village ordinance #145 - Unsafe Buildings violation has been adjudicated. Carried 6-0.

At 5:39PM, a motion was made by Junot and seconded by Lanctot to enter into executive session to discuss **DPW union negotiations**. Carried 6-0.

The meeting returned to regular session at 5:43PM.

A motion was made by Schneiderhan and seconded by Junot to accept the DPW contract. The new contract will add one day of sick leave/bereavement, is a 3 year contract until February 28, 2021, increases the part time garbage truck operator wage to \$13.50/hour and effective March 1, 2018: 4% wage increase, effective March 1, 2019: 2% wage increase and effective March 1, 2020: 2% wage increase. Carried 6-0.
